## Message from the Chair

Last year was an amazing and busy time to be Chair of IOIA. Covid-19 brought a whole new world to inspecting. We rose to the challenge in many ways to support our members, beginning with a committee of three volunteers (Patti Bursten Deutsch, Amanda Birk and myself, aptly called PAL's) to support inspectors with remote inspections. The work of PAL's paralleled that of the ACA Working Group which produced a Best Practice "Contingency Plans for Verifying Compilance when On-site Inspections are not Possible". These two initiatives responded to the urgency of the pandemic with lots of overlap and many hours. PAL's morphed into a Town Hall Committee with more members. We created guidance documents for remote inspections for processing and for requesting and gathering documentation from applicants. Patti and I made a video demonstrating ways to do remote inspections (I was the applicant and Patti the intrepid inspector --we had a lot of fun!). This committee grew with even more volunteers who gave many, many hours in creating a webinar training for remote inspections. I must recognize here the time donated by so many. Garth Kahl put in much time as we co-created this training. I am proud that this training has been translated into Spanish and is currently being used in several countries through a partnership with ClaO' (Comisión Interamericana de Agricultura Orgánica), about 20 countries who

have government regulated organic programs. Rachel Cherry Myers came up with the idea for a different format of presentation via a website that allows the inspector to choose where, when and what trainings they want to take. I put in about 300 volunteer hours in creating these trainings and working with the Town Hall Committee. Thank you, Amanda Birk, for chairing this committee and to Terrance "T" Layhew for moderating the Town Hall. The Town Hall helped to support and increase our membership and build community.

We rose to the challenge of the pandemic with creed/My and cooperation with our many partners. The efforts of our trainers, members, committees, and staff were simply HEROIC! Our Training Institute remained strong with 867 participants in 60 training events with 28 unique courses in 4 languages. I took our new Organic Cosmetics webinar. This is all amazing considering that the globe was basically in lockdown for months. We brought the inspectors' voice and perspective as we commented on the National Organic Program's Strengthening Organic Enforcement Draft Rule and the National Organic Standards Board's Human Capital Discussion Document on Inspectors and Reviewers. Our Annual Meeting in 2021 (record-breaking attendance) was held virtually, and while I was in line for my vaccination at San Diego's Petco Park parking lot!



It has been an amazing experience serving as your Board chair! I will continue to serve on the Mentorship and Fundraising committees. IOIA has so many important and exciting projects in the works! I am proud of all our collaborative efforts and honored to have served during this important time.

## IOIA's Training Institute trained more people in 2020 than in 2019! ...during a global pandemic.

Our innovative new formats for live online basic training and remote inspection training garnered IOIA a grant from Covid-relief through the state of Montana. IOIA trainers and staff generated training videos to replace on-site field trips. IOIA's in-person training came to a pause in February 2020 and is expected to resume in 2021.



For the first time, independent contractors were welcomed to the NOP certifier training, due to IOIA's efforts. The event included field trips, the Annual Meeting, advanced training, and "Conversation for a New Decade" with Sarah Brown, IFOAM North America; Michael Sligh, Alliance for Organic Integrity; and Nathaniel Powell-Palm.

#### Responding swiftly and decisively to Covid

IOIA and the Accredited Certifiers Association developed a best practice "Contingency Plans for Verifying Compliance when On-site Inspections are not Possible", and advocated for remote and hybrid inspections when on-site inspections could not be done safely.

#### **IOIA** built Community and Supported Inspectors

- **Town Hall** Epidemiologists, Accountants, Certifiers, NOP Deputy Director, inspectors roundtables. Many members said they found it key to helping them deal with the pandemic; 20 to 70 members attended.
- IOIA met with the Canadian Food Inspection Agency to advocate for inspectors.
- Kelly Monaghan fills our seat on the Organic Technical Committee in Canada.
- Started an improved Inspector's Forum online discussion group.



#### **Organic Integrity Learning Center Enhancement Project**

- In response to Covid, the Board and ED met with NOP Deputy Administrator Dr. Jennifer Tucker.
  That conversation led to a contract which kept inspectors working, safely, at a critical time; 70% of
  the funding went to 20 IOIA inspector contractors.
- From the joint press release "...organic inspectors, some of whom can't travel right now. To maximize the benefit of these inspector's expertise, a collaborative team (USDA NOP, A P Ventures, LLC, and IOIA) launched a project to pull in experienced organic inspectors to develop new learning content for the OILC."

#### 2021 Andrew Rutherford Award - Claudia Arellano, Sonora, Mexico

I am a Bio Food Processes Engineer. I worked directly with certifying organizations for 7 years approximately, in these years I was in charge of giving trainings about certification to the staff in production and in the field, including doing mass balance exercises and audit trails for our product.

I would like to join a certifier body or agency as an auditor, where I can continue to develop my understanding and continue my trainings and broadening my knowledge of the food industry. The next trainings that I will take will help me to increase my knowledge and will apply in my future employment, like being able to

better analyze and perform an audit, which is one of my goals to fulfill.

#### 2021 Organic Community Initiative Scholarship - Laura Gutiérrez, Jalisco, Mexico

I graduated in July of 2019 with a Bachelor's Degree as an Agricultural Scientist from the University of Guadalajara, in Jalisco, Mexico.

The last semester of my university career I left the city to do an internship with an agricultural company. This allowed me to be a part of real agriculture in which the main objective was to have high productivity, which is understandable, but not when done with unsustainable practices. As I became interested in what seems to me like a good alternative (organic agricultural practices), I began to investigate other types of management. First objective is resource preservation, always keeping respect for ecosystems in mind. Second, but not less important, is to form a community of peo-



ple interested in the preservation of resources (farmers) and healthcare with pesticide and GMO-free food (consumers). We can make the organic market a more attractive alternative for producers.

NOTE: The Board of Directors approved a balanced budget for 2020, with the expectation of a -\$85,000 bottom line. Members at the 2020 AGM were told that we expected to invest approximately \$85,000 in the Information Management System Technology upgrade, so we might have a -\$85,000 bottom line for 2020. The actual bottom line was -\$80,753.45. About half of that went to the technology upgrade. The other half can be attributed to training shortfall due to Covid and no in-person training events after February. Without a solid cash reserve, we could not have continued our programs. IOIA is accessing and using Covid resources. A Covid grant from State of Montana for \$12,500 was helpful. The OILC Enhancement Project contract offset much of the loss of income in IOIA's Training Program.


